**Entry Limit:** First 300 wrestlers will be accepted. ***NO LATE ENTRIES OR WALK-INS.***

**Brackets:** 4-man round robin, if possible with record and point system to determine medals for 3<sup>rd</sup> grade through old-timers. (7-win by fall, 6-win by technical fall, 5-win by major decision, 4-win by decision, 3-lose by decision, 2-lose by major decision, 1-lose by technical fall, 0-lose by decision)

**Weigh-Ins:** Home weigh-ins will be used. Random brackets will be checked. Must be within 3 pounds or disqualified.

**Scoring:** Pre-2<sup>nd</sup> grade is non-competitive with three 1-minute periods. 3<sup>rd</sup> and up is Folkstyle rules with Huskerland modifications: 3 1-minute periods, all starting in the neutral position. Overtime will be sudden death with a 1-minute period followed by a 30-second tiebreaker period if needed.

**Awards:** Pre-2<sup>nd</sup> all receive gold medals. 3<sup>rd</sup> grade – Old-Timer divisions receive medals for 1<sup>st</sup>-4<sup>th</sup> places.

**Officials:** High school wrestlers, Alumni wrestlers, and Club Coaches. Certified official on site.

**Admission Fee:** Adults-\$2.00, Students-\$1.00. Concession stand will be available.
